Jail For Indian In Sex Assault Case

DETROIT: A federal court has sentenced an Indian techie to nine years in prison after he was convicted of assaulting a sleeping woman on a plane.

The accused, Prabhu Ramamoorthy, will be deported to India after he completes his sentence. He procured an H-1B visa in 2015 and went to the US. The prosecutors wanted 11 years jail time.

The case: During a flight from Las Vegas to Detroit, Ramamoorthy assaulted his co-passenger while his wife sat next to him.

The evidence produced in court showed he digitally penetrated her while she was sleeping. When the woman woke up she found her pants unzipped and unbuttoned.

She then sought help from flight attendants and subsequent action was taken against him.

During the trial, Ramamoorthy gave an impression that he was a confused man and had no understanding of the language. The judge noted he had a high-end job requiring good language skills.
